

Privacy

This privacy policy sets out how **Gruppo De Angelis** uses and protects any information that you give **Gruppo De Angelis** when you use this website.

Gruppo De Angelis is committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

Gruppo De Angelis may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. This policy is effective from 10-12-2012.

What we collect

We may collect the following information:

- name and job title
- contact information including email address
- demographic information such as postcode, preferences and interests
- other information relevant to customer surveys and/or offers

What we do with the information we gather

We require this information to understand your needs for the purpose of conducting future business with you and for our marketing activities, such as writing to you with details of our services, to provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
 - We may use the information to improve our services.
 - We may periodically send promotional emails information which we think you may find interesting using the email address which you have provided.
 - From time to time, we may also use your information to contact you for market research purposes.
- We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interests.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about webpage traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

The **Gruppo De Angelis** website uses cookies to store some basic, essential data on your interactions with it, such as whether you have logged in. Other cookies state if you have previously logged into the website, and are optionally used to remember your login details for future visits.

Types of information stored:

Cookie based

PastMember: A PastMember cookie is set that recognises someone who visits who previously logged in. This cookie does not store personal information about you, but if you are a registered user it is used to update your personal record in the website database. This will be stored for 90 days.

alc_enc: If you check "Remember email and password for next time" a cookie "alc_enc" is set. This will be stored for 90 days.

Session based

PHPSESSID

This is used during your visit and is deleted when you leave the site. If you block this cookie parts of the site will not work properly or will be inaccessible to you as it is used for;

- CSRF-protection of forms
- Form error messages
- Tracking log-in
- GridField state

Links to other websites
